- Provide detailed audit and account analytics for greater visibility and transparency.



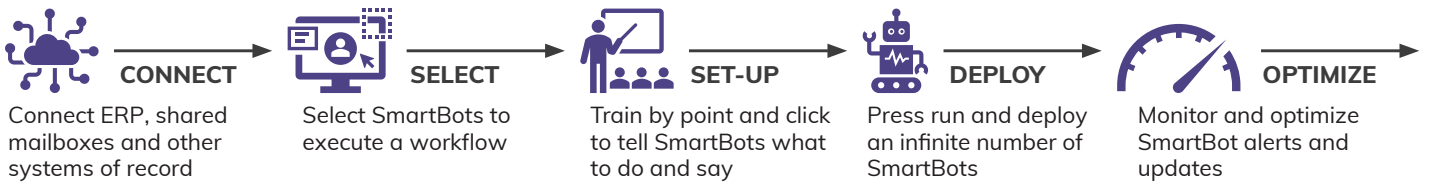
### AR HELPDESK

- Process email content and understand finance-specific intent to email authorized customers securely and protect sensitive accounting information, 24 hours a day, 7 days a week.

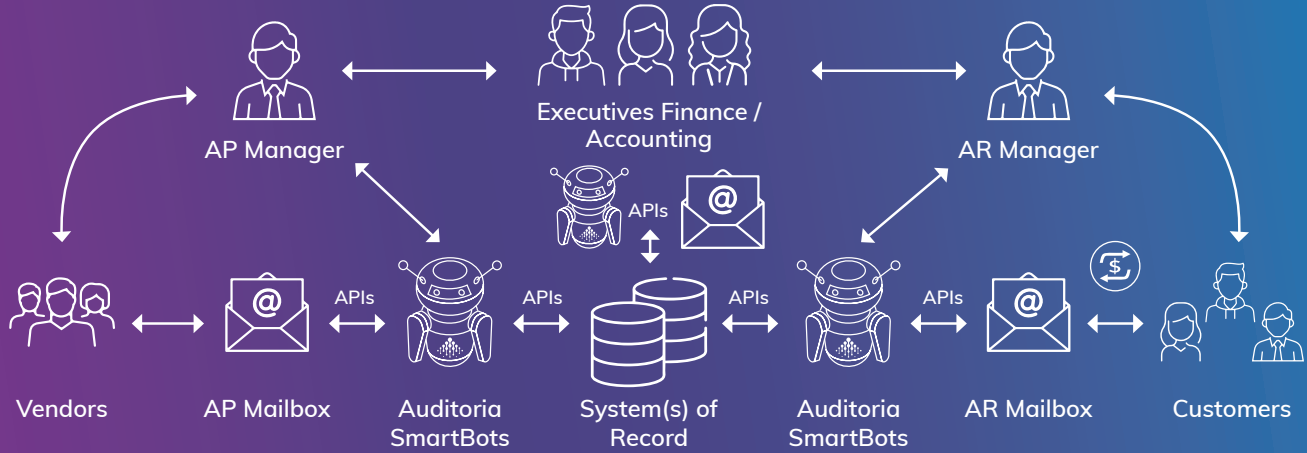


### AR REMITTANCES

### LARGE AND SMALL LANGUAGE MODELS TO OPTIMIZE FINANCE OPERATIONS

Auditoria's proprietary, patented small language model (SLM) offering combines LLM capabilities with finance-specialized data that allows for fine-tuned and customized finance context.

This specialty-built SLM comprising three billion tokens designed to understand and generate human-like finance text but is smaller in scale and yields more accurate results to radically improve outputs and workflows.



### HITL COLLABORATIVE MODE

Human in the Loop (HITL) functionality gives users the power to review and modify SmartBot actions, fine-tuning how the AI processes data and communicates with stakeholders.

This Collaborative Mode builds trust through hands-on engagement with the AI's decision-making process to improve the handling and recovery of exceptions.
